Also this year we are adding a stuffer to the fundraiser mailer. The board reviewed, made suggestions about the stuffer that will be going in the fund drive mailer.

Chief and Pate are working OCB Corporation that develops applications for smart phones. They make EMA, Police, Sherriff, Public Health and several other apps. It is \$3,500.00 to develop the app. We need an internal app to make it easier for them to submit drill exemptions, etc. We have about \$12,000 in Fire Prevention that can be used to develop this app. They met with OCB and they are very interested in developing the internal app.
